- Residential construction is under 3,500 square feet and/or when the electrical system rating does not exceed 400 amps
- Work completed by a governmental subdivision or state agency costing less than \$15,000.00 PLANS NOT REQUIRED

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No.299 or the Public Acts of 1980, as amended, and shall bear that architect's or engineer's signature and seal.

APPLICANT SIGNATURE

Section 23a of the state construction code act of 1972, 1972PA 230, MEL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of the state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subjected to civil fines.
