Item 1: Planning Discussion – Wind Power and Geothermal

Kathleen Jackson spoke to the discussion by the Planning Commission relative to wind power and regulation of same. Ordinances have been reviewed and more will be reviewed in the future for the type of regulation that is in other locations in Michigan. Currently, for utilization of wind power the only regulation necessary in Commerce is to comply with the height requirements of the Township. In addition, should regulations be put into place, there are no means of enforcement of same.

Also discussed was geothermal heating and cooling, which is the fastest evolving heat and cooling utility at this time. Grants are available for geothermal installation. More information will be forthcoming on this subject.

Item 2: Refinance of DDA Bonds

Tom Traciak, ACI Finance, gave a review and explanation of the refinance process. A summary of the DDA debt, structuring and refinance opportunities was also addressed by Bowden Brown. Charter One Bank was present with input relative to the refinance.

There are no time constraints to accomplish the refinance, downside is the cost of issuance of the new bonds.
